

DENTAL HYGIENE PROGRAM APPLICATION

Overview

The Diablo Valley College (DVC) Dental Hygiene Program is accredited by the American Dental Association Commission on Dental Accreditation (CODA) and approved by the Dental Hygiene Board of California (DHBC). The program will prepare you with the knowledge and skills to pass the required licensure examinations to become a Registered Dental Hygienist.

Scope of Practice

The DVC Dental Hygiene Program involves classroom and laboratory instruction and clinical experience, preparing you to perform procedures required of a dental hygienist. Skills include direct patient care, patient assessment, dental hygiene treatment planning, scaling, root planning, radiography, preventive measures, sealant placement, local anesthetic administration, nitrous oxide sedation, tooth whitening, and customized oral health education for individuals and groups. The California Dental Hygiene Scope of Practice (CA Bus & Prof Code § 1907-1915) is provided in the [Dental Hygiene Board of California Laws and Regulations Book](#).

Program Learning Outcomes and Graduation Competencies

Students completing this program will be able to:

- A. Synthesize knowledge from all branches of learning to provide preventive, educational, collaborative, and therapeutic dental hygiene care for individuals and groups in a variety of settings.

Policies for Admission

Admission to the DVC Dental Hygiene Program is based on the general admission policies for DVC (see the [DVC College Catalog](#)), guidelines consistent with state and federal law, and guidelines established by CODA and the DHBC. The program provides equal opportunity in education and employment and does not discriminate on the basis of race, color, national origin, sex, age or handicap in accordance with Titles VI and VII of the Civil Rights Act of 1964, Title IX of the Educational Amendments of 1992 and Section 504 of the Rehabilitation Act of 1973.

Prerequisite Coursework

All of the following science and general education prerequisites or equivalent courses must be completed with a grade of "C" or higher.

- Students must achieve a "C" grade or higher in each course to meet the program requirements.
- Prerequisite courses need to be taken only on a "for grade" basis.
- An overall GPA of 2.75 or higher in prerequisite coursework is required for program admission.
- Science courses must have been completed within the past seven years.
- In-progress coursework will not be accepted.

- CHEM 108-Introductory Chemistry

 - An equivalent course must include Biochemistry
 - An integrated Inorganic, Organic, Biochemistry course will not satisfy this requirement
- NUTR 160-Nutrition Science and Applications

General Education Prerequisites:

- COMM 120-Public Speaking or COMM 130-Small Group Communication
- ENGL 122-First-Year College Composition and Reading
 - Test scores of 3 or higher in AP English Language and Composition or AP English Literature and Composition will be accepted as equivalent
- SOCIO 120-Introduction to Sociology
- PSYCH 101-Introduction to Psychology or PSYCH 122-Psychology in Modern Life
- MATH 135- College Algebra or 142-Elementary Statistics with Probability
 - Any 3-unit or higher Math course that satisfies the CSUGE Area B4 or IGETC Area 2 requirement does not need course substitution
 - Test scores of 3 or higher in AP Statistics, AP Calculus AB, or AP Calculus BC will be accepted as equivalent

International Coursework

Foreign college transcripts must be translated/evaluated by a foreign evaluation service that is a NACES member. A list of NACES-approved credential evaluators is available at www.naces.org. The evaluation must include a course-by-course report with semester unit equivalencies that distinguish between upper- and lower-division coursework and include letter grades. If foreign coursework is to be used to satisfy a Dental Hygiene prerequisite, catalog descriptions will be required to show course equivalencies. English coursework taken at a foreign college will not equate to English 122.

Student Selection

Class space is limited to 20 students and will be determined by a lottery. Applicants successfully meeting the primary admission requirements will be entered into the lottery. Applicants will be notified by email of their provisional acceptance, non-acceptance, or rank on an alternate list by mid-April. If a provisionally accepted student declines their acceptance into the program, the position in the class will be awarded to an alternate. All provisionally accepted students will be required to attend an Orientation Course held in late April and early May. If a student does not attend all meetings or successfully pass the Orientation Course, the position in the class will be awarded to an alternate. The alternate list is only valid for the current application cycle.

Dental Hygiene Orientation and Program Entrance Requirements

Provisionally accepted students must enroll in and attend DENHY 101. Please check the DVC Spring Schedule for specific dates and times. Admission is contingent upon completion of this course with a grade of 75% or higher to formally be accepted into the Dental Hygiene program. If the student does not pass the orientation course, the position in the class will be awarded to an alternate.

Prior to the start of Summer courses, students who have successfully passed DENHY 101 will be required to show: (1) CPR/BLS certification for Health Care Providers; (2) current immunizations/titers following CDC guidelines for healthcare providers (Hepatitis B, Influenza, MMR, Varicella, Tdap, Meningococcal, and COVID-19 with booster); (3) proof of satisfactory tuberculosis (TB) screening; (4) current physical examination; (5) current vision exam; (6) passing background check; and (7) passing certified drug test. Reporting documents will be distributed with acceptance letters.

Becoming a Registered Dental Hygienist in California

All states require dental hygienists to be licensed. Licensure requires successful completion of an associate or baccalaureate degree from an accredited dental hygiene program, passing the National Board Dental Hygiene Exam, and a regional clinical exam. Effective January 01, 2024, students who graduate from an accredited dental hygiene educational program approved by the DHBC within the preceding three years may waive the requirement of a regional clinical exam.

Applicants must also be of good moral character and be citizens of the United States or lawfully entitled to remain and work in the United States with a social security number or individual tax identification number.

Certified Background Check and Drug Test

Live Scan fingerprinting is required and checked by the Department of Justice and/or the Federal Bureau of Investigation prior to state licensure. Each applicant must report any criminal record consisting of convictions or pleas of nolo contendere even if the conviction was dismissed or expunged. Past criminal records are evaluated carefully by the State and may result in denial of licensure.

- Applicants who have committed a felony should contact the DHBC to determine their eligibility.
- Making a false statement on an application regarding a past conviction is cause for denial of licensure, regardless of the nature of the crime or how long ago it occurred.

Any student with concerns regarding past criminal record should seek further information and clarification from the [DHBC](#) before undertaking the dental hygiene curriculum. Before the start of Summer courses, students who have successfully passed DENHY 101 will be required to pass a background check and a certified drug test. The drug test identifies Amphetamines, Barbiturate, Benzodiazepines, Cocaine, MDMA [Urine Testing], Methadone, Methaqualone, Opiates, Oxycodone, Phencyclidine, Propoxyphene. A positive result that cannot be justified by a physician's prescription may result in denial of acceptance to the program.

Program Cost Estimate

Application Procedures

It is the applicant's responsibility to comply with the following:

- The application filing period is **December 15 through January 15**.
- Complete application and supporting documents must be submitted online EXCEPT for official transcripts which must be sent to DVC Admissions and Records.
- Read each component of the application carefully. Incomplete applications will not be considered.
- **Use the Application Checklist at the end of the application to ensure the application is complete.**

Application Requirements

A complete application must include all of the following:

1. Completed Dental Hygiene Program online application form.
2. Completed Prerequisite Worksheet for Associate of Science in Dental Hygiene Degree.
 - Students must achieve a "C" grade or higher in each course to meet the program requirements.
 - Prerequisite courses need to be taken only on a "for grade" basis.
 - An overall GPA of 2.75 or higher in prerequisite coursework is required for program admission.
 - Science courses must have been completed within the past seven years.
 - In-progress coursework will not be accepted.
3. Completed Dental Office Observation forms dated within 24 months of the application filing period.
 - One form for prophylaxis or periodontal maintenance.
 - One form for non-surgical periodontal therapy (scaling and root planing).
4. In addition, **official** digital or hardcopy transcripts showing completion of all prerequisites must be **sent to DVC Admissions and Records**.
 - Official digital transcripts must be received directly from the granting institution or transcript vendor and sent to **transcripts@dvc.edu**.
 - Official hardcopy transcripts must be sealed by the granting institution, unopened, and sent to:

- OFFICIAL TRANSCRIPTS MUST BE RECEIVED BY DVC ON OR PRIOR TO JANUARY 15.

Exception: Transcripts are not required for coursework completed at DVC, Contra Costa College, or Los Medanos College.

If you wish to be considered as a candidate each year, you must submit a completed new application containing all materials as directed. **Application requirements may change from year to year.** Please refer to the DVC – [Dental Hygiene Program website](#) for the most up-to-date information regarding admission requirements.

Falsifying statements on the application, issues with the certified background check, or failing the drug test are cause for denial or dismissal from the program. The Dental Office Observation

The Diablo Valley College Dental Hygiene Program requires prospective dental hygiene students to observe two dental hygiene procedures to gain an understanding of dental and dental hygiene practices.

- One observations of a prophylaxis or periodontal maintenance appointment.
- One observations of a nonsurgical periodontal therapy (scaling and root planing) appointment.

Our goal is that applicants will be better informed regarding the daily activities of the clinical career path.

The applicant can observe 2 different hygienists in 2 separate offices or the same hygienist for both procedures. **Each** observation requires a minimum of 3 hours and a maximum of 8 hours. The observations must be completed and the forms signed by the dentist and dental hygienist regardless of the employment experience of the prospective applicant.

The forms must be submitted in PDF format.

1. The Dental Office Observation Form must be dated within 24 months of the application filing period.
2. Download and print the Observation Forms.

3. Complete required observations.
4. Upload the completed observation forms with all necessary signatures, license numbers, and dental office business cards.
